

WHAT DOES SUNSTONE MANAGEMENT INC. AND ITS AFFILIATED ENTITIES DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depends on the product or service you have with us. This information can include:

- Social Security Number
- Contact Information, such as telephone number, email and mailing address
- Investment Experience and Investment Profile
- Other information voluntarily provided to us when you make an investment or visit our website

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the types of information and purposes for Sunstone Management and its affiliates chooses to share personal information; and whether you can limit the sharing.

Federal law gives you the right to limit only:

Participate in voluntary surveys we may send out

State laws and individual companies may give you additional rights to limit sharing.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Sunstone Management, Inc., Sunstone Advisors, LLC, Sunstone Trust Company, Sunstone Community Fund
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.

Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
	Sunstone Management does not jointly market.

Other important information

- You have the right to correct any inaccurate information we have collected about you.
- You have the right to know what Personal Information we maintain on you.
- You have the Right to Opt-Out of our sharing your Personal Information for unaffiliated marketing purposes.
- You have the Right to be Forgotten or Deleted (except for information required to be maintained by us to provide services to you or which is required to be maintained by regulation or law).
